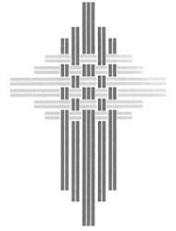

If email submission is not possible, you may submit your entry on CD or DVD by US Mail, however, you must mail identical entry packages to *each* of the 10 committee members. The names and addresses of these judges are also enclosed.

Please note that the deadline for entries is **July 1, 2010**. All winners will be notified by email and US Mail by August 15, 2010. There will be a formal presentation of awards to the winners at the ICSC annual conference to be held in San Diego, California on September 19-22, 2010.

In recent years, this process has been facilitated by Very Rev. Sylvester J. Cronin and the Department of Stewardship & Development in the Diocese of Metuchen, New Jersey. I want to recognize their diligence over the past few years, and thank them for their dedication and service.

Help Us Give Your Entry the Best Possible Consideration!

APPLICATION FORM:

1. Please use one (1) form per category.
2. Fill out the form completely and submit electronically.
3. Submit your materials along with the form.
4. Write the category being entered on the appropriate line.
5. Include your cardinal/(arch) bishop's name.

CATEGORIES:

1. For more than one entry, copy the Application and submit one form per category.
2. Include separate materials for each category (i.e., we cannot move materials from one category to another, or use one set of materials in two different categories).

VIDEO ENTRIES:

Each video entry should have a label that includes the following information:

1. Category.
2. (Arch) Diocese submitting the entry.
3. Run time of the video.

IF YOU ARE NOT ABLE TO SUBMIT YOUR ENTRY BY E-MAIL:

PACKAGING:

1. Multiple packages **must** be submitted to **each of the judges** listed on the attached page.
2. Place each category's entry in a separate container.
3. Materials should be on a CD or DVD.
4. Include the entry form for that category in the same container.
